Location Data




- What data exists that can tell us where a person(or device) is at a given time?





 - Mobile devices Phones, tablets, GPS and other mobile devices







- Most antennas have 3 sides

- If the cell site is busy the phone can connect to the next tower



 - Buildings







Stored Communications Act

(c) Records concerning electronic communication service or remote computing service.—

(1) A governmental entity may require a provider of electronic communication service or remote computing service to disclose a record or other information pertaining to a subscriber to or customer of such service (**not including the contents of communications**) only when the governmental entity—

(A) obtains a warrant issued using the procedures described in the Federal Rules of Criminal Procedure (or, in the case of a State court, issued using State warrant procedures) by a court of competent jurisdiction; [or]

(B) obtains a court order for such disclosure under subsection (d) of this section; * * *

(d) Requirements for court order.-- A court order for disclosure under subsection . . . (c) may be issued by any court that is a court of competent jurisdiction and shall issue only if the governmental entity offers specific and articulable facts showing that there are reasonable grounds to believe that the . . . records or other information sought, are relevant and material to an ongoing criminal investigation. * * * 18 U.S.C. § 2703
